Pursuant to 18 USC. §§ 2518, 2702, 3125 and any other applicable Federal or State statute, all lawful interception and location information assistance will terminate if the appropriate legal demand or customer consent is not received within 48 hours. The valid legal demand or customer consent should reference the existence of this exigent circumstance request. Use beyond 48 hours may also incur fees. This request is made pursuant to 47 U.S.C. § 222(g), 18 U.S.C. § 2702 and 47 C.F.R. § 20.18 and subject to state and federal perjury penalties.
